The parties agree as follows:

§ 1

The purpose of this letter of intent is:

1. Establishing mutual cooperation in order to import goods from regions outside the European Union to the European Union in order to sell them on the domestic market.
2. This letter of intent is a commercial agreement based on which the Eco 9QLive Foundation will conclude ancillary agreements on the purchase of products or goods on behalf of the Business Partner.
3. After signing the "Confidentiality Agreement", both parties will exchange sensitive data in order to prepare documents necessary to conclude agreements regulating the legal action of both parties.
4. Both websites are obliged to keep the information received in the utmost secrecy under the pain of criminal sanctions in accordance with the provisions of the European Union and its Member States.
5. The concluded contracts shall be drawn up in the official languages of both contracting parties, one copy for each contracting party.

§ 2

The Parties agree on the following priorities in mutual cooperation:

1. The Parties jointly declare that, pursuant to this letter of intent, they agreed on a common will to implement mutual commercial and business cooperation.
2. The scheduled performance of the contract will cover the period from 2022 to20 ...

§ 3

1. Detailed rules of cooperation and undertaken projects on the basis of this letter of intent, will be regulated in separate legal agreements between the contracting parties.
2. This letter of intent does not entail any obligations for either from the parties until the conclusion of the "Confidentiality Agreement" or other appropriate legal agreement regulating the principles of further cooperation.
